

Manitoba Last Will and Testament

Article I — Identification of Testator

I, the undersigned, being of legal age and of sound mind and memory, do hereby make, publish and declare this to be my Last Will and Testament, and I revoke all earlier wills and codicils made by me.

Article X — Survivorship Clause

A beneficiary must survive me by the number of days shown below in order to inherit under this Will. If a beneficiary fails to survive me by this period, they are deemed to have predeceased me for all purposes of this Will.

Article XI — No-Contest Clause

If any beneficiary contests this Will or any of its provisions, or joins any proceeding to contest its validity, that beneficiary shall forfeit their entire interest under this Will, and such interest shall pass as if that beneficiary had predeceased me. This clause is subject to applicable Manitoba law.
